

I'M NOT A MEMBER OF THE METTS SOCIETY OF SASKATCHEMAN BUT I HAVE A LOT OF FRIENDS SASKATCHEWAN BU! I MAKE A 101 OF FRIENDS OF INDIAN AND METIS ANCESTRY. I HAVE BEEN KEEPING CONTACT WITH THE "NEW BREED" AND ALSO ANY OTHER PAPER THAT HAVE STORIES CONCERNING INDIAN AND METIS.

I READ AN ARTICLE IN THE MEADOW LAKE PRO-GRESS CONCERNING A PROBLEM THAT HAD HAP-PENED WITH METIS PEOPLE. THE PERSON WHO PUT THIS LETTER IN THE PROGRESS KNEW WHAT SHE WAS TALKING ABOUT.

ARE THE METIS SOCIETY GOING TO DO ANYTHING ABOUT IT?

I UNDERSTAND THE METIS SOCIETY OF SASK-ATCHEWAN IS ONLY FOR PEOPLE OF INDIAN AN-CESTRY, I HAVE HEARD A LOT OF STORIES

CONCERNING THE METIS OFFICE IN MEADOW LAKE, WHEREAS JUST A FEW PEOPLE ARE BENEFITTING BY IT, AS THEY ARE OPERATING LIKE A SMALL MARIA. THEY PICK AND CHOOSE WHO THEY WANT TO TAKE ACTIVITY IN THEIR ENVIRONMENT. I BELIEVE THAT THE SOCIETY SHOULD INVESTIGATE A LOT OF THESE PEOPLE.

I'M SENDING A COPY OF THE PROGRESS PAPER FROM MEADOW LAKE WITH PICTURES OF PEOPLE WHO ARE OF COMPLETE WHITE ANCESTRY AND WHO ARE TAKING ADVANTAGE OF METIS ACTIVITIES AS THEY ARE CHOSEN O'VER THE TRUE INDIAN AND METIS PEOPLE. BECAUSE OF RUMOUNS I HAVE HEARD IN AND AROUND MEADOW LAKE AREA.

I FEEL THE ADMINISTRATORS OF THE METIS SOCIETY ARE FAILING TO DO THEIR JOB AS ELECTED LEADERS TO GIVE EQUAL RECOGNITION TO THEIR PEOPLE. WHEN LEADERS ARE LISTENING. TO THE PEOPLE WHO ARE CORRUPTING THE METIS SOCIETY RATHER THAN LISTENING TO THE PEOPLE WHO COUNT AS TRUE METIS BY DOING THIS THE METIS SOCIETY IS NOT DOING THEIR JOB FAIR AND SQUARE.

A FOSTER CHILD OF A METIS FAMILY. I FIND IT VERY

I HAVE HALF COUSINS STILL LIVING. ALL OF MY
FATHER'S HALF-SISTERS FOR SOME REASON PREFERRED

TO PASS THEMSELVES OFF AS BEING FRENCH. ALSO,
THEM APPLES WOULD NOT EVEN CALL THEMSELVES

FRENCH-CANADIANS. I THANK THE GREAT SPIRIT TO

LEARN THAT THE MAJORITY OF THE METIS ARE PROUD

IN REPLY TO YOUR LETTER I HISH TO DIRECT YOUR ATTENTION TO A COUPLE OF PERTINENT FACTS WHICH I THINK ARE VERY RELEVANT TO THE CONTENTS OF YOUR LETTER, FIRST OF ALL I THINK. IT WOULD BE SO EASY TO CLOSE OUR EYES AND EARS TO THESE FACTS AND WRITE ONLY ABOUT ALL THE GOOD THINGS HAPPENING TO OUR PEOPLE, BUT HAY ABOUT THE PLIGHT OF OUR MORE UNFORTUNATE BROTHERS AND SISTERS. IN ORDER FOR THEM TO GET ANY SORT OF FAIR SHAKE, THE FACTS HAVE TO BE BROUGHT OUT IN THE OPEN FOR PEOPLE TO KNOW ABOUT, THAY WAY THINGS CAN BE DONE - BUT, BY SWEEPING IT UNDER THE CAMPET WE ARE AS GUILTY AS THE PERSON WHO CAUSED THEIR SUFFERING ABOUT AND PICTURED. THE HOUSING CONDITIONS WE WROTE ABOUT AND PICTURED WAS BONE TO HELP THE PEOPLE WHO NEED IT - BY PUTTING IN ALL THE GOOD HOMES AND THERE ARE SOME, WE ARE NOT SETTING THE POINT ACROSS THAT THERE ARE MANY OF OUR PEOPLE WHO, NEED AID AND NEED IT BADLY, THESE ARE THE ONES WE WANT TO HELP IF AT ALL

I SINCERELY APPRECIATE YOUR CONCERN AND HOPE YOU WILL ARITE AGAIN, KEEP UP THE STRUGGLE AND BE CONCERNED AND LET US KNOW YOUR VIEWS ANYTIME.

MEETINGS HAVE BEEN HELD THROUGHOUT THE NORTH AND SOUTH LATELY TO DISCUSS THE FORMING OF A NEW DEPARTMENT OF NORTHERN SASKATCHEMAN. MEETINGS WERE HELD IN THE FOLLOWING PLACES:

AT WHICH TIME DELEGATES FROM ALL LOCALS IN THE NORTH AND FROM THE SOUTH DISCUSSED THE FOLLOWING PROBLEMS:

EDUCATION WELFARE TOURISM INDUSTRY EMPLOYMENT HEALTH D.N.R. MINERAL RESOURCES TIMBER RIGHTS LAND OWNERSHIP

THE NEW PROPOSED "DEPARTMENT OF NORTHERN SASKAT-CHEWAN AND IT'S BROTHER ACT "DEVELOPMENT OF HUMAN RESOURCES IN SASKATCHEWAN" WILL BE COVERING ALL THESE AREAS. THEY WILL COME UNDER ONE DEPARTMENT AND ONE MINISTER WILL BE ADVISED BY A "MORTHERN ADVISORY BOARD" APPOINTED BY THE GOVERNMENT. 

AND EVEN SO, THE MINORITY OF THE LAW PEOPLE IN THIS "KANGAROO" SET UP ARE TIED IN WITH HYPOCRITICAL POLITICS, SO FOR THE SAVE OF THAT ALONE THEY MUST FOLLOW THE RULES OF JUSTICE LAID DOWN BY THE SWEET LAWS OF THIS COUNTRY, A SAD BUT EXIST-ING FACT.

STACE, SO AGE YOU REPINE YOUR FINNERS CROSSED AND HOPE THAT THIS WILL SHEEP DON'S ALL THE NOISE AND CRYING ABOUT INJUSTICE! IF YOU ARE, YOU GAN UN-CROSS YOUR FINNERS AND FORCE! IT, BECAUSE OUT-RIGHT DISCRIMINATION IS A THINK THAT IS NOT EASILY BROSED FROM A PREJUDICED.

AN INDIAN GETS A PRISON TERM AND HE APPEALS AND GETAINS THE FORTUNATE HAPPENING OF WINNING AN INVEDIATE RELEASE ONLY TO BE RES-CHARGED ON THE SAME THING MORER DIFFERENT CIRCUMSTANCES UPON HIS RETURN TO HIS HOME. AND HE STILL BIDS UP DOING TIME ON THESE WIERD CIRCUMSTANCES!!) THAT'S JUSTICE?

A COMPLAINANT DROPS CHARGES AGAINST AN ACCUSED PERSON AND A CUPUCITIONI DROPS CHARGES AGAINST AN ACQUISED PERSON AND STILL THE ACQUISED PERSON ENDS UP SERVING A PRISON TERM WITH THE COMPLAINANT'S TESTIMONY. TO ELABORATE A EIT, IT WORKS LIKE THE CASE WHERE THE COMPLAINANT FRALIZED HE OR SHE MORE A MISTAWE IN A STATE OF INTOXICATION BY LAYING A CHARGE OF ASSAULT (IN A LOT OF CASES). SO HE OR SHE PROCEEDS TO TRY AND DROP CHARGES, BUT FOR SOME STRANGE REASON THIS CONT. THE DONCE - AS A RESULT THE ACQUISED PERSON IN THIS COMPLICATED MIX-UP IS SENT INTO A JAIL. 
