Emma Rose Sansaver (St. Sauveur). (1884-1925)

Emma was born in 1884 near Havre, the daughter of Edward St. Sauveur¹ (1859-1891) and Marie Rose Laframboise. Marie was born in 1858 near Prince Albert, the daughter of François Laframboise, (Métis) and Marie Trottier², (Métis). She married Edward St. Sauveur in 1875 at Edmonton.

Emma Rose was a member of a girls' basketball team that was organized at Fort Shaw School in 1902. Emma and her younger sister Flora had attended St. Paul's Mission School at Fort Belknap before transferring to Fort Shaw. In 1903, the team twice defeated the women's basketball team from Montana Agricultural College, once in Great Falls (36-to-9) and again in Bozeman (20-to-0). The Fort Shaw girls defeated nearly every high school and college girls' basketball team in the state, as well as several high school boys' teams. The team ended its first year as undisputed (if unofficial) state champion.

In 1904, school superintendent Fred Campbell agreed to send his girls' basketball team to the Louisiana Purchase Exposition, better known as the St. Louis World's Fair, in St. Louis Missouri. To fund their trip, the team stopped at numerous points along the way to play exhibition games against other high school and college girls' teams. After each game, the girls donned traditional native ceremonial garb and charged a fee (50 cents) for a program of dance, music, and recitations.

Part of the United States' pavilion at the World's Fair was a Model Indian School. The girls would live and take classes at the school, and twice a week would hold intrasquad exhibitions. The girls also agreed to take on all challengers. The girls departed from Fort Shaw on June 1, 1904. The 11 girls defeated every single team they played over the next five months, earning themselves the title "world champions."

Over the course of five months, more than three million fair-goers gaped at Indian students demonstrating their skills in domestic and industrial arts, drama, and music. However, the almost all-white audience devoted most of its fascination to ten Indian girls playing basketball and, between games, reciting Longfellow's "Hiawatha" in distinctive buckskin dresses. Her scrip application in 1885 had affidavits signed by Basil Parenteau of St. Boniface and Moise LaPierre of Turtle Mountain.

Marie notes that the family was employed freighting from Cypress Hills to Fort Benton. They lived at Swift Current, Duck Lake and Carlton before that time.
