SUBJECT: METIS NATION OF SASKATCHEWAN CONSTITUTION

The Metis Nation of Saskatchewan Constitution is a living document which must evolve as we move towards self-governance. Further to this we have seen some areas which require revision to reflect present realities since its inception in 1993. We have established a Commission for the purpose of reviewing the MNS Constitution. This will allow for community input into a document to be presented to the Provincial Metis Council, the MNS Senate, Metis Nation Legislative Assembly, Annual General Meeting and Metis Women of Saskatchewan.

The duration of the Commission will be short (February 1 - 28, 1997), so it is incumbent upon you, the members of the MNLA to contact your constituents and be prepared to represent their views at the hearing in your region. Please note that there are no funds available for travel, so you are on your own for expenses.

Commission members include: Lorna Docken, MNS Provincial Secretary and Earl Pelletier, Clerk of the MNS Senate. They will act in an impartial manner in an attempt to solicit as many viewpoints as possible. Please cooperate with them and offer your assistance as participants.

We have enclosed for you a Mission Statement, Goals of the Commission, Terms of Reference, Schedule, Consultation Survey Questions and an MNS Constitution. Please circulate these as widely as possible so that your constituents are ready when the Commission visits.

- 5. To develop a report to the MNS Provincial Metis Council, MNS Senate, Metis Women of Saskatchewan, Metis Youth and the Metis Nation Legislative Assembly, Annual General Meeting in July, 1997.

## TERMS OF REFERENCE

The President of the Metis Nation of Saskatchewan has struck a Constitution Review Commission to review the MNS Constitution. The Commission is comprised of MNS Provincial Secretary, Lorna Docken and Earl Pelletier, Clerk of the MNS Senate.

The schedule of hearings will be conducted from February 1 - 18, 1997.

Hearings and meetings will be held in all of the MNS Regions and will seek out as many views on the MNS Constitution as possible. These views will be sought through community consultations, public meetings, personal interviews, mail solicitation, and questionnaire responses. Questionnaires will be sent to all of the MNS Locals and each Local is requested to respond to the questionnaire. The questionnaires and feedback will be documented and analyzed to prepare a report for the Provincial Metis Council, the Metis Nation Legislative Assembly, the MNS Senate, Annual General Meeting, and the Metis Women of Saskatchewan. The report will also form the basis for more discussion and potential amendments, changes, and/or ratification at the Metis Nation Legislative Assembly.
