"To develop, implement and manage our own justice and social programs in order to ensure that our children have a healthier environment in which they can flourish."

BACKGROUND

Métis Family & Community Justice Services of Saskatchewan, Inc. was incorporated in 1992 as an affiliate of the Métis Nation — Saskatchewan as a result of our recognition of the need to empower Métis communities to address the social and justice issues facing our people. Our mandate is to promote the spiritual and cultural well being of Métis individuals, families and communities throughout Saskatchewan.

The focus of MFCJS is on supporting the delivery of holistic, community-driven social and justice services in a manner that values and utilizes the wide range of geographic and demographic needs and resources within the Métis Nation - Saskatchewan. Our priority is the promotion of strong Métis family values as the core of our Nation. We envision an environment in which Métis children are protected and cared for by their families and communities. We rely on the knowledge and experience of our Elders to ensure that programs and services will be delivered in a holistic, culturally sensitive manner.

MFCJS is governed by a Provincial Board of Directors consisting of:

- Marianne Gagnon, Associate Minister,
- representation from Métis Women of Saskatchewan,
- representation from Métis Youth Council and
- representation from each MN-S Region,

Over the past 10 years, MFCJS has implemented various initiatives ranging from the Aboriginal Court Worker, Community Justice Development, Social Development, Community Action Program for Children, Prenatal Nutrition, as well as numerous other short term services.

CURRENT

Over the past year, MFCJS has maintained long-standing partnerships with Health Canada, Sask. Justice/Justice Canada and as well as developing new initiatives with Corrections Services Canada; the Commission on First Nations and Métis Peoples and Justice Reform; National Crime Prevention – Community Mobilization; Department of Social Services; MN-S Tripartite

These partnership have resulted in the development and delivery of the following programs;

Saskatchewan Aboriginal Court Worker Program

The role of the Court Workers is to ensure that Aboriginal people who are charged with a criminal offence and/or family members of the accused receive just, equitable and culturally sensitive treatment. The Aboriginal Court Workers ensure that each client fully understands the criminal justice processes which they will be involved in and has the support that they need. Priority is given to first and second time offenders.

MFCJS Court Workers have developed excellent working relationships with Court personnel. This has proven to be an asset in working with our clients and assisting them in reducing the linguistic barriers and cultural misunderstandings between themselves and employees of the Criminal Justice system.

MFCJS currently has 2 full-time positions serving the provincial court areas of Saskatoon, Beardy's First Nations, Rosthern, and Blaine Lake.

Commission on First Nations and Métis Peoples and Justice Reform

MFCJS was approached by the Commission in mid-April 2002 for the input of Métis people across Saskatchewan to the justice forum.

Through many negotiations with the Commission, Alex Maurice and the office personnel, an agreement was finally made. In June, the staff of MFCJS redesigned the 1997 Justice Survey and handed it out to as many MNS members as they could at the AGM.

Jennifer Conley was hired as a ½ time Researcher on September 9, 2002, to work closely with the Commission but to be employed by MFCJS. Over the past nine months Jennifer has traveled extensively with the Commission to many communities across Saskatchewan and attended a multitude of presentations made by various organizations. The Commission on First Nations and Métis Peoples and Justice Reform is now in the process of winding down the consultation phase of their term and will now begin writing the final report. The next interim report will be released in September 2003 and the final report is targeted to be released in March 2004. Correctional Service of Canada

MFCJS contacted Frankie Berland of the MNC to negotiate on our behalf for an initiative that was proposed for reintegrating Métis offenders back into their communities. The result of this was that were contracted by Shelley Trevethan, the Director of the Research Branch, Correctional Service of Canada, to initiate a research project for the reintegration of Métis offenders in Saskatchewan. The research projects are being carries out respectively in three phases.

<u>Phase I</u> - This project examines the needs of Metis offenders inside of federal correctional facilities in Saskatchewan. The project involved interviews with Metis offenders and family members, as well as with parole officers. This information should help CSC and Metis organizations to better understand how to implement Section 81 and 84 of the CCRA for Metis offenders. The Correctional Service of Canada funded this project. CSC is still compiling and analysing the data, which we are anticipating will be sent in the next few months.

<u>Phase II</u> - The purpose of this research project is to compile information to be used in the development of the five-year strategic plan in regards to Community Justice and Corrections for Métis Family and Community Justice Services Inc. This phase involves visiting Métis communities that have been identified by the Métis inmates and by MFCJS. Activities will include conducting community needs assessments and consultations, identifying community needs, gaps, priorities and potential partnerships. The Solicitor General, Aboriginal Corrections Policy Unit will be funding this phase.

<u>Phase III</u> – In this phase, a five-year strategic plan will be developed to guide discussions with Métis stakeholders for the delivery of community-based justice and corrections programs and services, which support the successful reintegration of Métis offenders in Métis communities.

MFCJS is currently at the end of phase I and we are anticipating completion of the final report within the next few months. We are very excited about the report and the findings of the research. We are now moving into Phase II which will involve conducting community needs assessments in three selected target communities: Beauval, Saskatoon and Fort Qu'Appelle. These communities were selected based on phase I research findings and Solicitor General's funding guidelines. Phase II will involve indepth community profiles, interviews with key community members, leadership and service providers. This information will assist MFCJS in the development of Phase III, a five-year strategic plan for MFCJS as well as identifying the needs of Métis offenders and their family members in Saskatchewan.

The purpose of these projects is to facilitate the development of Section 81 and 84 for Métis inmates being released from federal institutions as well as development of a five-year strategic plan for community-based justice and corrections programs and services.

Tripartite Justice

As of April 1, 2002, MFCJS was reintroduced into the 2002-2003 Tripartite work plan. Utilizing Tripartite funds to supplement existing budgets, MFCJS was able to undertake and/or expand several initiatives in the 2002 – 2003 fiscal year that support MN – S/MFCJS participation in the Aboriginal Justice Strategy. MFCJS strongly believes in a holistic approach to the development and healing of our communities. Therefore, several other initiatives have been maintained and/or established promoting this perspective. These initiatives include both provincial and federal partnerships such as National Crime Prevention – Community Mobilization, Department of Community Relation and Employment (formerly Department of Social Services, Correctional Service of Canada, Solicitor General of Canada and, Health Canada. MFCJS is anticipating receiving Tripartite this year although the MN-S is still in the negotiation process.

Justice Workers co-ordinate the provision of;

- diversion/alternative measures hearings;
- mediations, family/group conferences;
- healing and sentencing circles; and the recording of minutes for such processes; and
- maintenance of a tracking system of client files, crime rates and other relevant statistics.

Commission on First Nations and Métis Peoples and Justice Reform

In the summer of 2001, the Government of Saskatchewan determined that it was desirable and in the public interest to establish a Commission on First Nations and Métis Peoples and Justice Reform to review the justice system with the intent of devising solutions to overcome systemic discriminatory practices and address attitudes based on racial and cultural prejudice. In the spring of 2002, MFCJS was approached by the Commission to assist them in their efforts to gather input from Métis people across Saskatchewan.

In partnership with Saskatchewan Justice, we have implemented a Justice Research initiative which will liase with Métis individuals and communities to ensure that their perspectives, experiences and recommendations are reflected in any reforms which may be undertaken by the government.

The Saskatoon Metis Elders Mentorship Project

The Saskatoon Metis Elders Mentorship Project was implemented in February 2002 in partnership with National Crime Prevention - Community Mobilization. The goal of this project is to develop an appropriate mentorship model that reflects Metis culture and

values. In order to achieve this goal a Co-ordinator was hired to work with the Metis Elders Working Committee to assist in documenting Metis culture and heritage.

The Saskatoon Metis Elders Mentorship Project objectives are:

- document and promote the revitalization of Metis traditions, culture and family values;
- Develop networking and partnerships with existing services;
- Develop recruiting and ongoing screening processes

The Saskatoon Metis Elders Mentorship project ended March 31, 2003 and we are currently utilizing the remaining funds to assist in the Elder's Forum scheduled for July.

Social Development/Capacity Building Project

Based on the MOU signed in 1998 between the Department of Social Services, the Métis Nation-Saskatchewan and MFCJS, a provincial Social Development/Capacity Building was signed in the fall of 2002. The objective of this agreement is to build capacity within the Métis community to support the strategic direction of Social Services within the scope of Child & Family Services.

The objectives of this project are to:

- provide consultation to the department on the design and delivery of services and programs to ensure cultural relevance and sensitivity;
- liaise with DSS staff and the Métis community in the development of policy to support culturally appropriate programs and services for Métis children and families;
- provide a written report to the Department identifying outcomes and recommendations of the Métis Children's Wellness Conference to be used in the development of a child and family focussed workplan.

In February, 2003, MFCJS, in conjunction with the MN-S hosted a 3 day Métis Children's Wellness Conference. The focus of this consultation was the development of a Draft Child and Family Services Policy and Action Plan. In follow up to this, a meeting was held between MFCJS, MN —S and Minister Hagel of the Department of Community Resources and Employment (formerly Department of Social Services) on June 11th, 2003. Discussions involved the long-term processes and capacity-building required to implement these documents. The concept of a joint management committee was presented and further discussions will take place over the summer to define terms of reference and specific roles and responsibilities of each partner.

In the short term, the Department has indicated that they would be willing to support prevention and diversion initiatives as a first step in building partnerships and capacity within our communities. MFCJS is currently working with the Department and 3 MN-S Regions to build on existing contracts and/or develop new partnerships. The projected start date of these initiatives is September 01st, 2003.

Métis Community Development and Research - Community Action Program for Children (CAPC)

The Community Action Program for Children is a federal initiative designed to help community groups address health and developmental needs of high- risk children (0-6 years) and their families. Guiding principles of CAPC are:

- Children first:
- Strengthening and supporting families;
- Equity and accessibility;
- Partnerships
- Community-based;
- Flexibility.

Métis Family and Community Justice Services, Inc. (MFCJS) – Métis Community Development and Research is intended to empower families and communities as they develop knowledge and skills through designing and implementing programs and services. It is not intended to duplicate or replace other government programs, but rather to work with existing federal, provincial and community programs. This program will assist Métis Regions in accessing funding and developing proposals for children. As well, they organize and co-ordinate community forums to provide information on available resources and how to access them. Specifically, MFCJS – Métis Community Development and Research will:

- support designated CAPC Projects;
- provide community development/research support for existing and potential projects;
- improve Métis linkages and identify gaps in services;
- ensure programs reflect Métis culture, beliefs, values and traditions;
- deliver relevant training, as requested;
- attend meetings and workshops pertaining to children's issues;
- act as liaison and support to Health Canada, in particular Health Canada Program Consultants.

Saskatchewan Métis Urban Youth Center Initiative - Canadian Heritage

MFCJS is currently working with the Saskatchewan Métis Urban Youth Committee (SMUYC) and the Department of Canadian Heritage in developing an agreement for the administration of the funding allocation under the terms and conditions of the Urban Multipurpose Aboriginal Youth Center (UMAYC) Initiative.

Following completion of the application review process, a provincial proposal will be submitted to the Department for review and recommendation to the Minister of Canadian Heritage. If accepted, the contracting process will take place and the 03/04 funding allocation will be distributed to those applicants who have been recommended for funding by the SMUYC.
