Métis Nation Gathers to Discuss Upcoming Negotiations With the Federal Government

August 27, 1998

(Richmond, BC) – The Métis National Council is holding a General Assembly in Vancouver, British Columbia, August 28-29, 1998. This milestone event shall be provide a foundation for the Métis people as they prepare a Métis Nation Agenda for the new millenium.

Minister Goodale will address over 150 leaders of the Métis Nation from Ontario, Manitoba, Saskatchewan, Alberta, British Columbia, the Northwest Territories. The main focus of Minister Goodale's address will be the Métis Nation Agenda Action Plan. This action plan is a direct response to the Final Report of the Royal Commission on Aboriginal Peoples.

The Métis National Council will establish a Métis-specific agenda to guide negotiations with the federal government on a wide range of issues including:

- ∞ Rights
- ∞ Land Claims
- ∞ Enumeration
