Presentation by Lance LaRose and Ingrid of the Metis Family & Community Justice Services. Lance reports on what's happening with justice development in the province. At present focusing on areas such as Meadow Lake, Buffalo and Ile la Crosse. Lance spoke on the Court Worker Program in the Battlefords, Lance stated that we should be involved in the Youth diversion within the BattlefordsOther items included Partnership with Health Canada. Lance is presently working on putting togather a Elder Workshop (3 days) to invite 200 elders dealing with issues of health, social, justice. Lance is awaiting to hear from the Social Services department with regards to input in the budget. Ingrid worked on the Metis foster care in the Saskatoon district., found that there were only 14 foster family homes in Saskatoon and wondered what the provincial scope would be like. She would like to work with in the twelve regions regarding foster care. She also spoke of the new agreement between Sask-tel and Social Services that provides telephone service to low income reciepants, statements are sent directly to the Social Service office for payment.
